



## Read all instructions carefully and completely before installing your new slip-on mufflers

- 1. Loosen the front and rear clamps on the catalytic converter heatshield. Remove the rear clamp and then swing the heatshield down so the muffler clamp can be accessed. See **Figure** 2.
- 2. Loosen the muffler clamp and remove the two bolts in the muffler bracket. Then slide the muffler backward off the headpipe.
- 3. Slide the supplied muffler clamp over the slip-on muffler and position it as shown in **Figure 1** with the hex head facing inward and down.
- 4. Slide the muffler onto the headpipe until the mounting holes align. See Figure 2.
- 5. Fasten the muffler using the supplied mounting bolts in the same manner as stock but **do not tighten.** Install the catalytic converter heatshield and verify that the gap, where the muffler meets the catalytic converter heatshield is similar to the gap the stock muffler allotted.
- 6. Check all the clearances and alignments then tighten the muffler clamp and catalytic converter heatshield clamps. (NOTE: The muffler clamp should be flush with the end of the muffler when tightened. See **Figure 1**. If the muffler clamp is slid forward past the slots on the muffler slip the clamp will not tighten the muffler properly). Tighten the mounting bolts to factory specifications.
- 7. IMPORTANT: Before starting your engine remove all fingerprints from all exhaust surfaces. To clean your black exhaust system use a liquid based soap detergent, such as dishwashing soap applied with a soft cloth and rinse with clean water. Note: Avoid abrasive cleaning methods such as granular or dry cleansers, simple green, scotch-brite or steel wool pads. Abrasives may breach the coating and shorten life.
